City of Spencer Regular Council Meeting August 28, 2025

Mayor Farmer called the regular council meeting to order. Roll call was taken, with the following alderman present: Darrell Nance, Drew Campbell, Jody Hensley and David Chandler. Also in attendance were City Attorney Ed Boring, Police Chief Scott Garing, Officer Michael Hickman, Codes Official Chad Moffitt, City Recorder Crystal Crain, Court Clerk Tabitha Robinson. This was followed by a prayer and the pledge. Mayor Farmer requested approval of the previous regular council meeting minutes as written. Alderman Chandler made the motion to approve the minutes as written, which was seconded by Vice Mayor Campbell. All were in favor and the minutes were approved. Mayor Farmer opened the floor for citizen comments; however, there were none at this time.

ITEM #1: Deacon Weeks to Address the Board Regarding Complaint. Mr. Weeks. Mr. Weeks read the letter he had submitted as his written complaint. Complaints included building permits, property taxes, and water quality. Mayor Farmer asked, what action the board would like to take. The board declined to make a motion.

ITEM #2: Leo Sochocki to Address the Board Regarding Hometown Heros. Mr. Sochocki gave all the Alderman his business cards and passed around the awards he plans on giving out at the Hometown Heros event. He asked the Alderman to personally donate to the event, and funds will go into the pantry account. The event will also be giving a scholarship away to a deserving senior who will be going into a first responder field. He is excepting five hundred people to be in attendance. He will have awards for the volunteer fire departments, EMS, police, and utility. No action taken was taken by the board.

ITEM #3: Discussion of City Park Vandalism Situation. Mayor Farmer explained the person responsible for the vandalism has admitted guilt and will be handled through the court system. Mayor Farmer just wanted to make sure the board is aware and to be thinking.
