ITEM #4: Resolution 2024-9, Appointment of Brandon Griffin as Special Substitute Municipal Judge. Mayor Farmer asked the board on how to proceed with selecting a new Municipal Judge. The Board chose for the office to accept resumes and bring back to the board to discussion.

ITEM #5: Approval to apply for the TDOT 80/20 grant for additional funds for the SRTS Sidewalk Grant. The match would be ~~\$62,489~~ \$62,478. Zeda reminded everyone the city had bid opening last month and bids came in higher than expected. We have since reached out to the school board to help with the matching funds. The school board approved to pay half the match in the amount of ~~\$31,244.50~~ \$ 31,239. Alderman Chandler made the motion to apply for the additional TDOT grant with the 80/20 match along with the school paying half. Alderman Blankenship seconded the motion.


